[In the case of] *The King vs. William Hands, Esq.*, on an indictment for a negligent escape, the defendant, being arraigned, pleaded not guilty and informed the Court that he was not ready for trial.

Barnard Buckley included in the indictment against Daniel McIntosh et al; ignor'd, discharged by proclamation.

[In the case of] *The King vs. Patrick Powers* on an indictment for uttering counterfeit money, the prisoner, being arraigned, pleaded not guilty et po se.

Barnard Buckley bound in £10, conditioned for his personal appearance at this Assize, when called to give evidence on the part of the Crown against Wm. Hands, Esq., in a case of negligent escape.

Samuel Hamlet bound in £25 and John Sirens bound in £25, conditioned for their personal appearances respectively at the present Assizes when called, to give evidence on the part of the Crown before the Grand Jury and the Court, touching a certain indictment preferred against William Grey in a case of receiving stolen goods, and not departing hence without leave of the Court.
