Document 1862-#10, Diary of a Journey over the Addington Road and part of the Addington & Renfrew Road, September 1-5, 1862, prepared by Ebenezer Perry (Numeric Land Files, RG 1-246-3, Box F81)

September 1st: Left Tamworth at 6 a.m. Examined Archibald Campbell's gift lot. Found all requirements performed. Found some settlers who had not repaired the road acrost their lots. Saw them and warned them to do it immediately. Arrived at Scouten's Inn at 12 o'clock. Fed and dined, left at 1 p.m. Proved a transfer of gift lot No. 22 in Anglesea from Mr. [Robert] Campbell to Mr. [William] Wallace. Examined said lot and ascertained that the settling duties had been performed prior to the transfer of it. Noted those settlers who had not done their repairs on the road. Arrived at Davis Hawley's at ½ past 7 p.m. Made 33 miles.

September 2nd: Left Davis Hawley's ½ after 6 a.m. Saw several parties about repairs on road. Examined the bridge at the head of Mazinaw Lake. Found that the south end had sunk (the south shore being more or less quicksand). The water in the lake is much higher than usual. Enquired of Messrs. Kenyon and Wickware the probable cause. Was informed that in their opinion, it was caused by a dam erected at the foot of the lake by a Mr. Snider. Arrived at Mr. [John] Pake's in Abinger at 1 p.m., dined and fed. Left at 2 p.m. Made engagements to examine 3 gift lots on my return. Found the road materially injured by fire on the 48th, 50th and 51st miles against lots unoccupied. Arrived at Madawaska bridge after sundown. Could not get feed for my horse. Was obliged to ride to Highland Creek farm, a distance of 5 miles, after nightfall. Arrived at 8 p.m. Made 34 miles.

September 3rd: Left Highland Creek farm at 6 a.m. on foot, having learned from Mr. Thomas McGregor that a horse could not pass over the damaged road with safety. Found 53 pieces of the centre of a bridge or high causeway over a cedar swamp destroyed and one rod of the eastern approach of said bridge was also burnt. A bridge of two rods long over a spring brook badly damaged. Those causeways or bridges are on the 15th mile. On the twelfth mile, I found a side embankment injured by holes being burned out nearly acrost the track. I filled them up temporarily with blocks and stones, proceeded to within 10 miles of the Opeongo Road, and returned to the farm ½ after 12 noon. Dined and rested until 2 p.m., when I started homeward. Examined Mr. [John Benjamin] Thompson's gift lot and Mr. [David] Switzer's gift lot in Denbigh, ascertained that the requirements were not completed, arrived at Mr. [John] Pake's, rear of Abinger, at nightfall. On foot and horseback made 33 miles.

September 4th: Left Mr. Pake's at 7 a.m. Examined lots No. 36 in Abinger and No. 36 in Anglesea. Found the lot in Anglesea all right. Arrived at Davis Hawley's at 2 o'clock p.m., dined and occupied the remainder of the day in making enquiries about Mr. Roy's claim for dues for saw logs cut on his lot by Messrs. Gilmour & Co., which was referred to me under date of 25th August last past. During the afternoon, I examined gift lot No. 29 in Barrie [lot of Timothy Pringle], found improvements completed thereon. Worked up to 6 o'clock p.m. Made 17 miles.

September 5th: Saw by appointment Mr. Roy at 6 a.m., and several other parties mentioned in Mr. Orleans Hart's affidavit about logs cut in 1859 and 1860. Closed my enquiries at 9 a.m. Left and saw Messrs. Dempsey, Deighton, Winters and Quackenbush about causeways that are

June 29th: [9] men + 2 carters employed: Two men ½ day finishing the Bass Creek bridge. About 80 feet of bridge covered new. Two men with pickaxes. Five men with shovels. Two men ½ day clearing out road. One mile of road made. Two carters drawing dirt and gravel for road.

June 30th: 9 men + 2 carters employed: Two men clearing out road. Two men with pickaxes. Five men with shovels. ¹/₄ mile of road made. Two carters drawing dirt and gravel for road.
