According to a Roman Catholic register of North Crosby Twp., Sarah Ann was born January 21, 1859 to James McCann and Mary Byrnes. A family tree on Ancestry states that this Sarah Ann married William P. Brennan ca. 1882. The couple lived in Youngstown, Ohio. She died on November 21, 1938 in Youngstown. The 1871 census of North Crosby Twp. also contains the listing of 12 year old Sarah McCann, born in Ontario. She is in the family of farmer Samuel McCann (44) and his wife Sarah (45). James Lakins, 40, mechanic of North Crosby Twp., born in North Crosby to Abraham Lakins and Agnes Dowdale, married Mary Mitchell, 32, of South Sherbrooke, on March 16, 1879 in South Sherbrooke. A family tree on Ancestry states that Abraham and Isaac are the same man, married to Agnes Nancy Dowdall.
